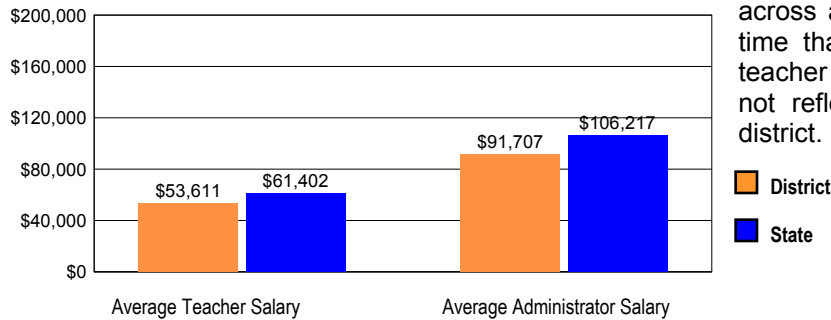

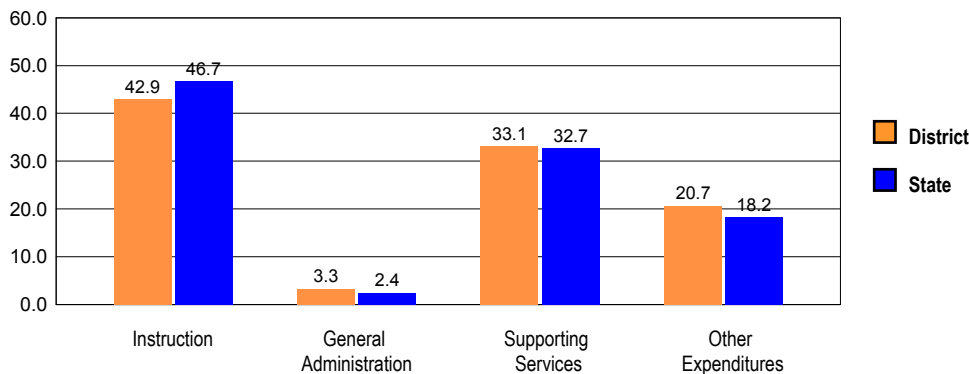
SCHOOL DISTRICT FINANCES

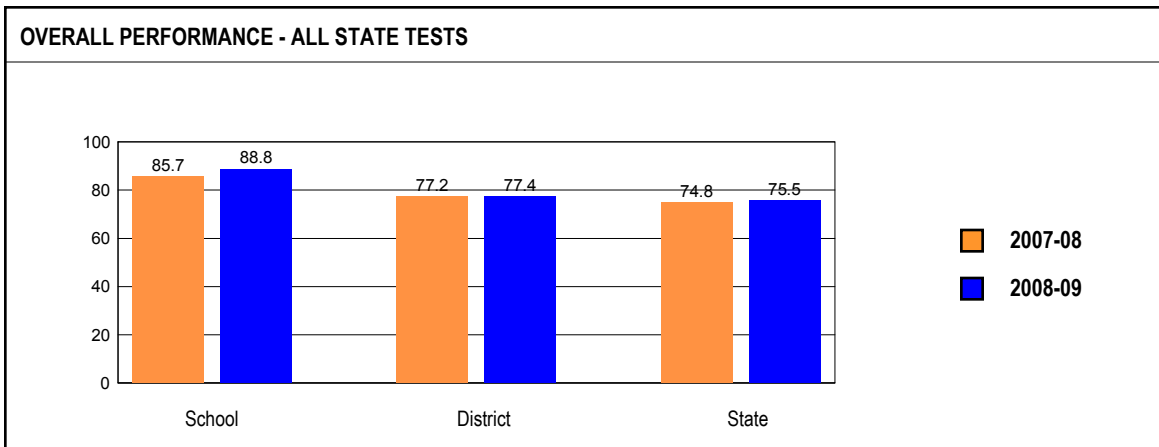

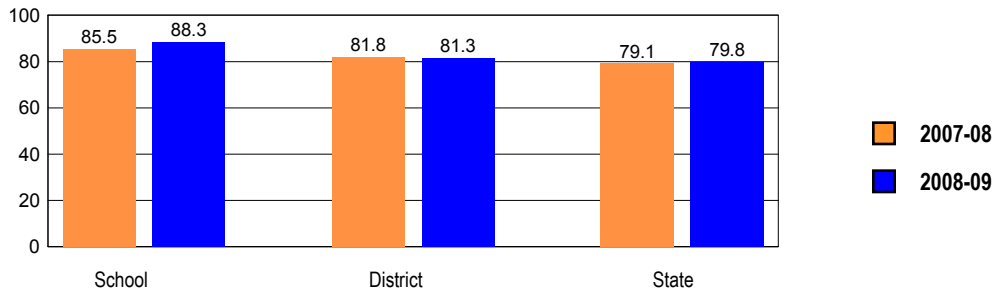
OVERALL STUDENT PERFORMANCE

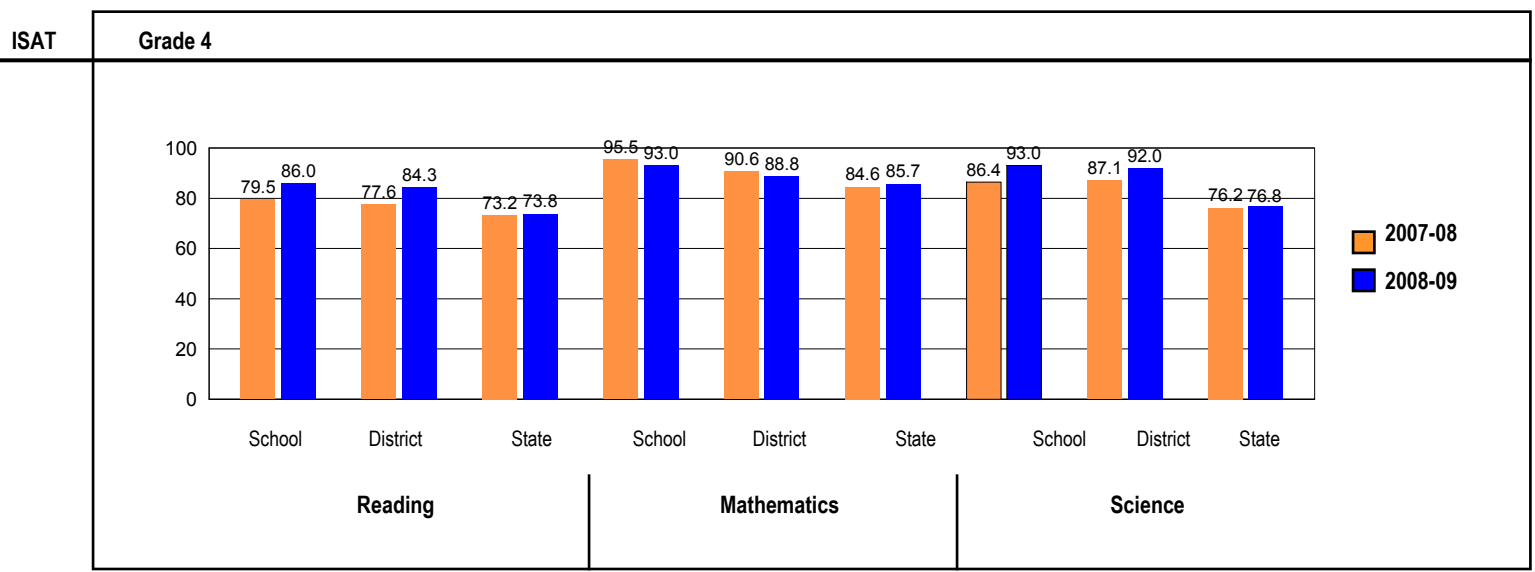
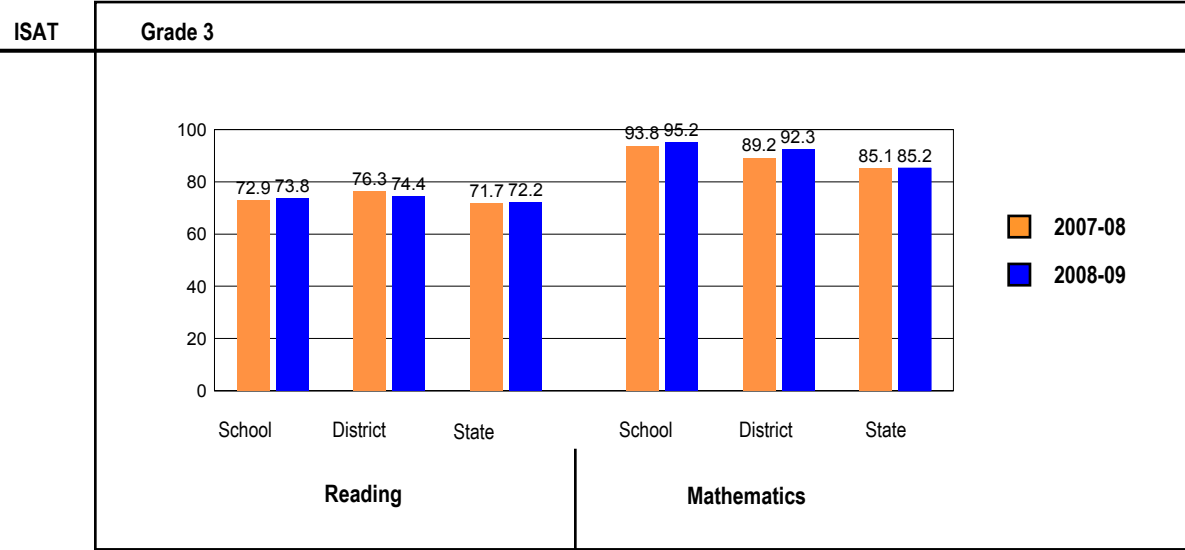


OVERALL ILLINOIS STANDARDS ACHIEVEMENT TEST (ISAT) PERFORMANCE

PERFORMANCE ON STATE ASSESSMENTS

Federal law requires that student achievement results for reading, mathematics, and science for schools providing Title I services be reported to the general public.

The Illinois Standards Achievement Test (ISAT) is administered to students in grades 3 through 8. The Prairie State Achievement Examination (PSAE) is administered to students in grade 11. The Illinois Alternate Assessment (IAA) is administered to students with disabilities whose Individualized Education Programs (IEPs) indicate that participation in the ISAT or PSAE would not be appropriate.

Students with disabilities have an IEP (No Child Left Behind Act). An IEP is a written plan for a child with a disability who is eligible to receive special education services under the Individuals with Disabilities Education Act.

Reading and Mathematics are tested in grades 3 through 8 and 11. Science is tested in grades 4, 7, and 11.

In order to protect students' identities, test data for groups of fewer than ten students are not reported.

ILLINOIS STANDARDS ACHIEVEMENT TEST (ISAT)

The following tables show the percentages of student scores in each of four performance levels. These levels were established with the help of Illinois educators who teach the grade levels and learning areas tested. Due to rounding, the sum of the percentages in the four performance levels may not always equal 100.

Level 1 -- Academic Warning - Student work demonstrates limited knowledge and skills in the subject. Because of major gaps in learning, students apply knowledge and skills ineffectively.

Level 2 -- Below Standards - Student work demonstrates basic knowledge and skills in the subject. However, because of gaps in learning, students apply knowledge and skills in limited ways.

Level 3 -- Meets Standards - Student work demonstrates proficient knowledge and skills in the subject. Students effectively apply knowledge and skills to solve problems.

Level 4 -- Exceeds Standards - Student work demonstrates advanced knowledge and skills in the subject. Students creatively apply knowledge and skills to solve problems and evaluate the results.

Four Conditions Are Required For Making Adequate Yearly Progress (AYP):

1. At least 95% tested in reading and mathematics for every student group. If the current year participation rate is less than 95%, this condition may be met if the average of the current and preceding year rates is at least 95%, or if the average of the current and two preceding years is at least 95%. Only actual participation rates are printed. If the participation rate printed is less than 95% and yet this school makes AYP, it means that the 95% condition was met by averaging.
2. At least 70.0% meeting/exceeding standards in reading and mathematics for every group. For any group with less than 70.0% meeting/exceeding standards, a 95% confidence interval was applied. Subgroups may meet this condition through Safe Harbor provisions. ***
3. For schools not making AYP solely because the IEP group fails to have 70.0% meeting/exceeding standards, 14% may be added to this variable in accordance with the federal 2% flexibility provision.
4. At least 90% attendance rate for non-high schools and at least 78% graduation rate for high schools.

** Safe Harbor Targets of 70.0% or above are not printed.

*** Subgroups with fewer than 45 students are not reported. Safe Harbor only applies to subgroups of 45 or more. In order for Safe Harbor to apply, a subgroup must decrease by 10% the percentage of scores that did not meet state standards from the previous year plus meet the other indicators (attendance rate for non-high schools and graduation rate for high schools) for the subgroup. For subgroups that do not meet their Safe Harbor Targets, a 75% confidence interval is applied. Safe Harbor allows schools an alternate method to meet subgroup minimum targets on achievement.

Jefferson Elementary School Report Card

Wrap-Around '09

Analysis of Jefferson School students' scores on the Illinois Standard's Achievement Test (ISAT) for the 2008-2009 school year indicate the Jefferson School did meet AYP in the areas of Reading, Mathematics, and Science.

At the third grade level, 74% of Jefferson students met or exceeded the state standards in reading, and 95% of Jefferson students met or exceeded standards in math. Jefferson Elementary students did meet AYP in the third grade in the area of Math and Reading.

At the fourth grade level, 86% of Jefferson students met or exceeded the state standards in reading, 93% of Jefferson students met or exceeded the state standards in Math, and 93% of Jefferson students met or exceeded the state standards in science. Jefferson Elementary students did meet AYP in the fourth grade in the areas of Math, Reading, and Science.

The following improvements have been made in an effort to increase student achievement and to raise test scores and meet AYP at Jefferson School.

1. Shurley English series implemented for 1st-4th grades.
2. I-STEEP adopted to benchmark and progress monitor K-4 students in reading and math.
3. Student Intervention Team (SIT) continued to help identify and monitor at-risk students.
4. Continue to utilize NCLB aides for grade K-4 to serve all grade levels for small group at-risk instruction.
5. Continued use of "BEE Your Best" School-wide Discipline Policy.
6. Advanced technology available in all classrooms.
7. Continue the RTI (Response to Intervention) program.
8. ISAT test-prep through Study Island online grades 3-4.
9. Continued use of CATCH PE components and equipment in PE
10. Improved and expanded PTO to increase parental involvement.
11. 100% K-4 classroom teacher website usage.
12. Continuation of Special Education SRA Reading Mastery & Corrective Reading
13. Teachers attend many workshops on a variety of topics to improve student academic success.
14. Regular and Special Education faculty co-teaching to eliminate duplication of service and maximize teacher to student time.
15. School social worker implanting the Second Step Program K-4.
16. Phones added in all rooms.
17. Updated visual appearance of school's interior.
18. Continuation of communication across grades and teachers.
19. Continuance of test preparation for ISAT in Math, Reading, & Science.
20. Document Readers available in all classrooms.
21. New music curriculum program implemented.
22. Continued focus on math facts (+,-,x,÷)

Suggestions for Improvement:

1. Still need an additional NCLB aide to cover all at-risk math students.
2. Training needed for all teaching assistants and aides.
3. Smaller teacher to student ratio.
4. Continued maintenance and improvement of technology.
5. New Reading and Social Studies Curriculum.
6. Formation of Reading Curriculum Adoption Committee.
7. New technology software utilized through the free online program: *Balabolka*.
