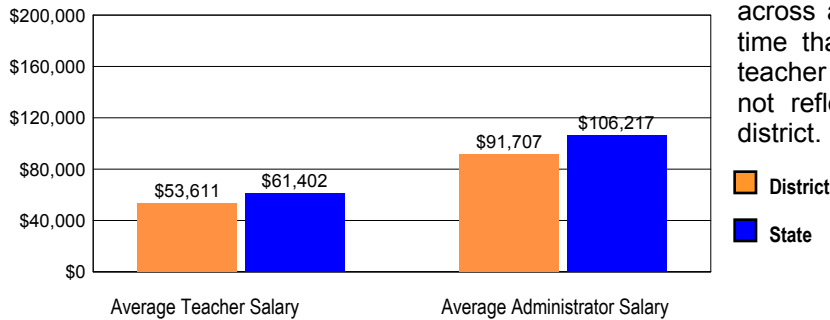

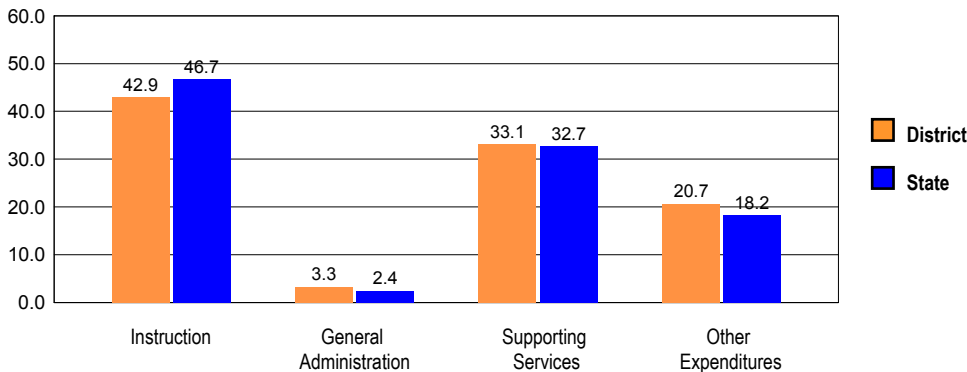
SCHOOL DISTRICT FINANCES

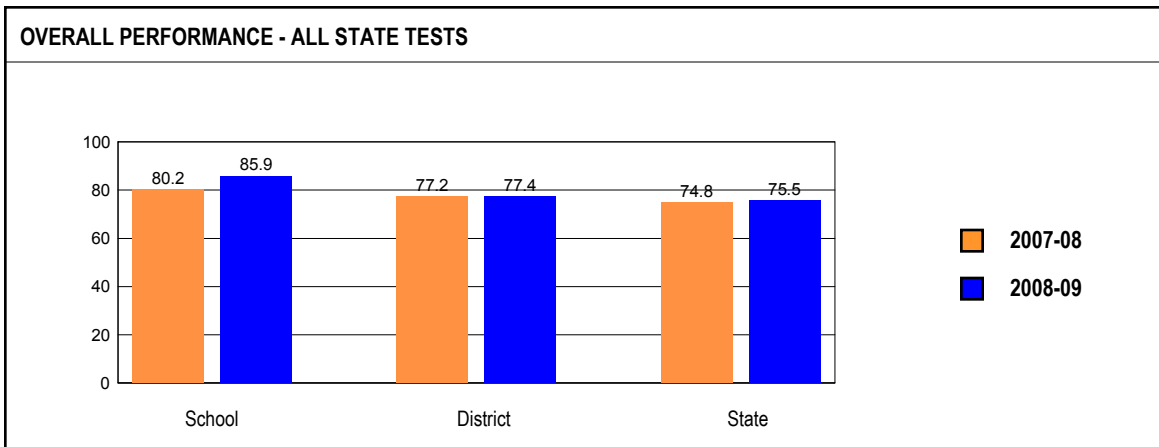

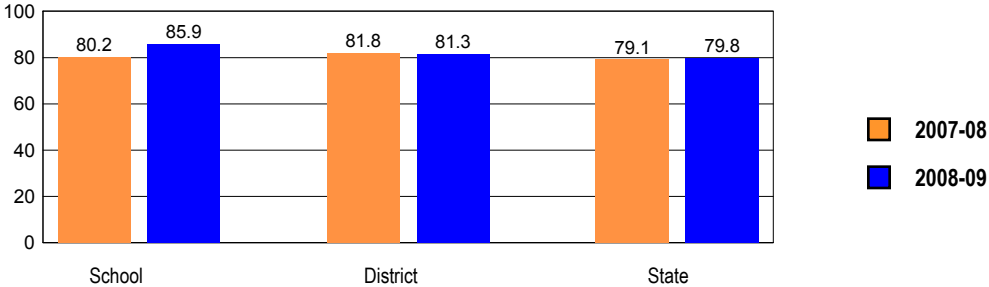
OVERALL STUDENT PERFORMANCE

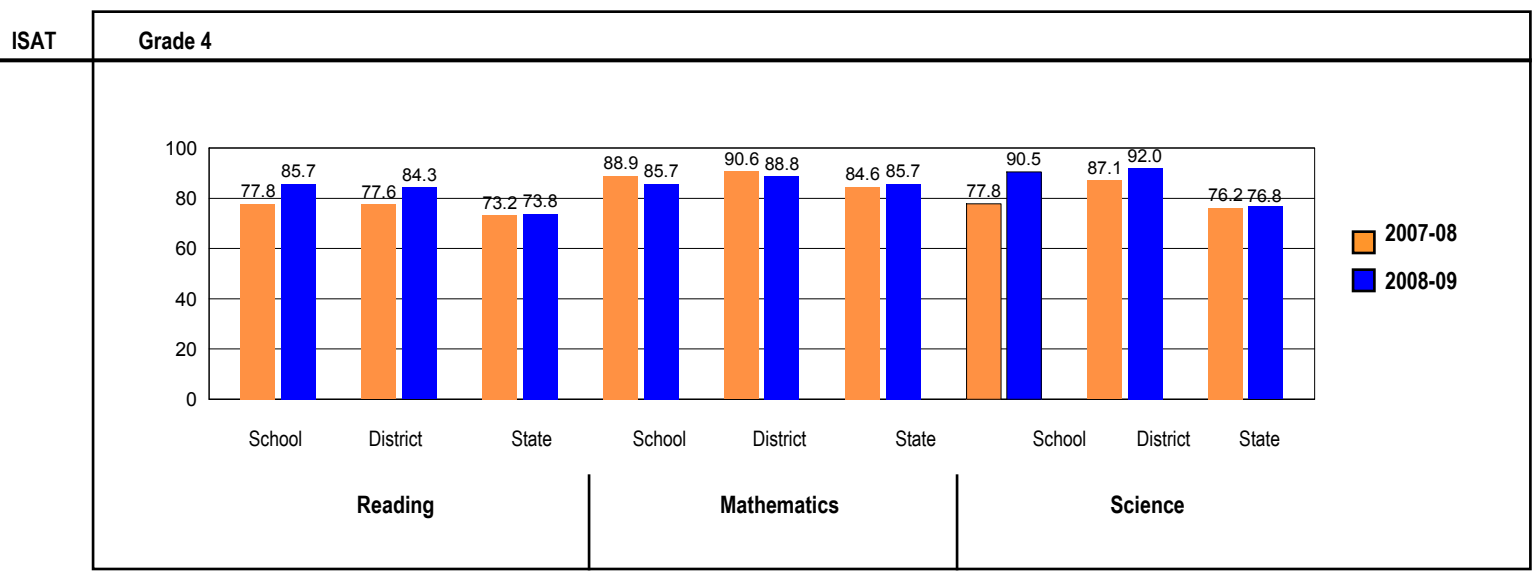
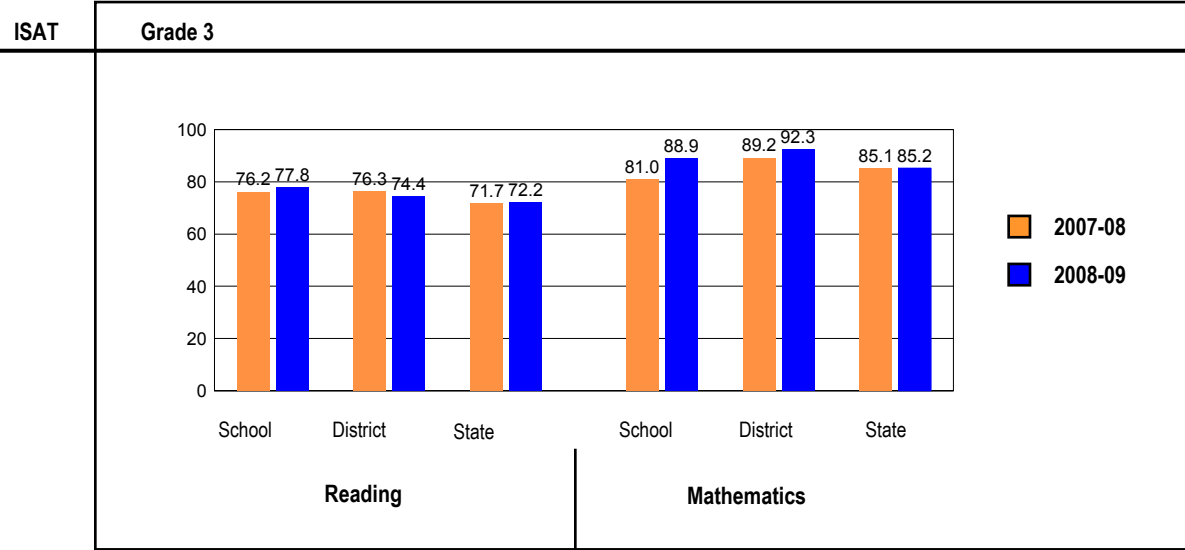


OVERALL ILLINOIS STANDARDS ACHIEVEMENT TEST (ISAT) PERFORMANCE

PERFORMANCE ON STATE ASSESSMENTS

Federal law requires that student achievement results for reading, mathematics, and science for schools providing Title I services be reported to the general public.

The Illinois Standards Achievement Test (ISAT) is administered to students in grades 3 through 8. The Prairie State Achievement Examination (PSAE) is administered to students in grade 11. The Illinois Alternate Assessment (IAA) is administered to students with disabilities whose Individualized Education Programs (IEPs) indicate that participation in the ISAT or PSAE would not be appropriate.

Students with disabilities have an IEP (No Child Left Behind Act). An IEP is a written plan for a child with a disability who is eligible to receive special education services under the Individuals with Disabilities Education Act.

Reading and Mathematics are tested in grades 3 through 8 and 11. Science is tested in grades 4, 7, and 11.

In order to protect students' identities, test data for groups of fewer than ten students are not reported.

ILLINOIS STANDARDS ACHIEVEMENT TEST (ISAT)

The following tables show the percentages of student scores in each of four performance levels. These levels were established with the help of Illinois educators who teach the grade levels and learning areas tested. Due to rounding, the sum of the percentages in the four performance levels may not always equal 100.

Level 1 -- Academic Warning - Student work demonstrates limited knowledge and skills in the subject. Because of major gaps in learning, students apply knowledge and skills ineffectively.

Level 2 -- Below Standards - Student work demonstrates basic knowledge and skills in the subject. However, because of gaps in learning, students apply knowledge and skills in limited ways.

Level 3 -- Meets Standards - Student work demonstrates proficient knowledge and skills in the subject. Students effectively apply knowledge and skills to solve problems.

Level 4 -- Exceeds Standards - Student work demonstrates advanced knowledge and skills in the subject. Students creatively apply knowledge and skills to solve problems and evaluate the results.

Four Conditions Are Required For Making Adequate Yearly Progress (AYP):

1. At least 95% tested in reading and mathematics for every student group. If the current year participation rate is less than 95%, this condition may be met if the average of the current and preceding year rates is at least 95%, or if the average of the current and two preceding years is at least 95%. Only actual participation rates are printed. If the participation rate printed is less than 95% and yet this school makes AYP, it means that the 95% condition was met by averaging.
2. At least 70.0% meeting/exceeding standards in reading and mathematics for every group. For any group with less than 70.0% meeting/exceeding standards, a 95% confidence interval was applied. Subgroups may meet this condition through Safe Harbor provisions. ***
3. For schools not making AYP solely because the IEP group fails to have 70.0% meeting/exceeding standards, 14% may be added to this variable in accordance with the federal 2% flexibility provision.
4. At least 90% attendance rate for non-high schools and at least 78% graduation rate for high schools.

* Includes only students enrolled as of 05/01/2008.

** Safe Harbor Targets of 70.0% or above are not printed.

*** Subgroups with fewer than 45 students are not reported. Safe Harbor only applies to subgroups of 45 or more. In order for Safe Harbor to apply, a subgroup must decrease by 10% the percentage of scores that did not meet state standards from the previous year plus meet the other indicators (attendance rate for non-high schools and graduation rate for high schools) for the subgroup. For subgroups that do not meet their Safe Harbor Targets, a 75% confidence interval is applied. Safe Harbor allows schools an alternate method to meet subgroup minimum targets on achievement.

The faculty and administration met to discuss and analyze students' test scores on the Illinois Standards Achievement Test. The results and analysis of the 2008-2009 ISAT for Lincoln Elementary School are as follows:

3rd Grade – Tested in Reading and Math

77.8% of our 3rd grade students met or exceeded state standards in Reading.

88.9% of our 3rd grade students met or exceeded state standards in Math.

4th Grade – Tested in Reading, Math, and Science

85.7% of our 4th grade students met or exceeded state standards in Reading.

85.7% of our 4th grade students met or exceeded state standards in Math.

90.5% of our 4th grade students met or exceeded state standards in Science.

Overall, we are pleased with our students' performance on the 2008 ISAT tests. While we are delighted with most of our scores, we also have some areas of concern. **We are very proud that over 85% of our students met or exceeded state standards in Math and over 80% of our students met or exceeded state standards in Reading.** We believe with a concentrated effort among faculty and administration we can continue to improve in these areas. We impress upon each of our students that there is always room for improvement. To help maintain and strengthen our overall commitment to make certain that the students at Lincoln Elementary School meet or exceed state standards, we will make certain that our staff targets and continues to align our curriculum to the Illinois State Learning Standards. An extensive effort is being made by our administration and faculty to continue to improve reading scores in the district.

Other areas that we believe have enhanced a positive and productive learning environment are:

- Staff utilization of Heggerty Phonemic Awareness
- All classes are setting goals in Accelerated Reading
- ISAT training in Reading, Writing, and Math
- Progress Monitoring all students in the area of reading
- Purchased many new books for the library
- Students have access to a school counselor/implemented instruction in emotional
- Expanded the RtI/Aspire program for struggling readers
- SRA reading series in all classrooms, including special education
- Weekly assemblies that promote and reward positive behavior.
- Updated curriculum maps
- CATCH PE
- District wide grade level meetings to discuss curriculum

- Updated technology
- SmartBoards and projectors installed in each classroom for interactive instruction
- Elementary PE teacher/curriculum
