Johnston City School District Unit # 1 is committed to providing a quality education for each student in our district. As a district we recognize that parents are an integral part their children's academic success. When families and schools work together to promote student achievement the benefits to the students are immense. Therefore we support and encourage teacher and parent partnerships to encourage academic success for all students.

Johnston City School District Unit #1 recognizes that some students may need the extra assistance available through the Title I program to reach the state's high academic standards. Johnston City School District intends to include parents in all aspects of the school's Title I school-wide program. The goal is to create a strong partnership between school and home so that every child succeeds.

PART I General Expectations

The Johnston City School District agrees to implement the following statutory requirements:

- 4. The Johnston City School District will provide parents of participating children information in a timely manner about Title I, Part A programs that includes a description and explanation of the school's curriculum, the forms of academic assessment used to measure children's progress, and the proficiency levels students are expected to meet by:
 - Informational Letter
 - Title I compact
 - Teachers send home mid-quarter reports
 - Intensive and strategic intervention effectiveness are shown with progress monitoring
 - Istation benchmark scores can be shared with families on a monthly basis.
 - Teachers use a variety of ongoing parent communication tools that include telephone calls, e-mails and letters and notes home to families.
- 5. The Johnston City School District will at the request of parents, provide opportunities for regular meetings for parents to formulate suggestion and to participate, as appropriate, in decisions about the education of their children. The school will respond to any such suggestions as soon as practicably possible by:
 - Parent Orientation Nights at the beginning of each school year
 - Pre-School/Kindergarten Readiness Presentation (Spring)
 - Evening programs during the year where teachers and families participate together
 - Weekly newsletters promote school/family connection
 - Counselor and/or principal meet with families and teachers to discuss any specific concerns
 - E-mail correspondence between parents and teachers
- 6. The Johnston City School District will provide each parent an individual student report about performance of their child on state assessment in math, language arts and reading by:

- ISAT results sent home to parents
- 7. The Johnston City School District will take the following actions to provide each parent timely notice when their child has been assigned or has been taught for four or more consecutive weeks by a teacher who is not highly qualified within the meaning of the term in section 200.56 of the Title I Final Regulations (67 Fed. Reg. 71710) by:
 - Letter
- 8. The Johnston City School District will provide assistance to parents of children served by the school, as appropriate, in understanding topics by undertaking the actions described below:
 - School report card
 - How to monitor their child progress
 - State and local assessments
 - How to work with educators
 - Illinois Learning Standards
 - Website links
- 9. The Johnston City School District will provide materials and training to help parents work with their children to improve their academic achievement, such as literacy training and using technology, as appropriate, to foster parental involvement by:
 - Continuous meetings with parents of students who are performing below their peers. These meetings are conducted every 4-6 weeks.
- 10. The Johnston City School District will, with the assistance of its parents, educate its teachers, pupil services personnel, principals and other staff in how to reach out to, communicate, and work with parents as equal partners in the value and utility contributions of parents, and how to implement and coordinate parent programs and build ties between parents and schools, by:

- Williamson County Early Childhood Pre K Family Educator programs.
- Parent Liaisons located at Lincoln, Jefferson, and Washington Elementary.
- 11. The Johnston City School District will, to the extent feasible and appropriate, coordinate and integrate parental involvement programs and activities with SIUC Head Start, and Williamson County Early Childhood Pre K that encourage and support parents in more fully participating in the education of their children.
 - Johnston City Pre-schools, Head Start and Kindergarten teachers and the community will participate in a Kindergarten Readiness Awareness Training (providing materials and resources to families with preschool aged children)
